COURSE DESCRIPTION

Fundamentals of investigation; techniques of crime scene search and recording; collection and preservation of physical evidence; modus operandi processes; sources of information; follow-up and background investigation and surveillance. Special section on fingerprint classification.

COURSE OBJECTIVES

When presented with basic techniques of crime scene sketching, the student will be able to satisfactorily analyze and compile data for use in formal presentation of evidence in court. Given case studies and role play situations, the student will demonstrate basic investigative proficiency, to the satisfaction of the instructor, by synthesizing a situation

and reducing the crime to reportable elements.

3. The student will demonstrate the basic steps of investigation, observation, and effective analyses, communication, and presentation of physical evidence for prosecution.

PROGRAM OUTCOME

The community college affords the appropriate academic environment for the student to concentrate on an in-depth study of the fundamentals of criminal investigation. Surveys of law enforcement academy programs show that recruits get only a limited exposure to the concepts of criminal investigation. Since a majority of law enforcement functions evolve around the investigative function, a person is not prepared to conduct an effective investigation unless the fundamental concepts of an investigation are properly executed. Lost cases and embarrassing situations arising from field operations can usually be traced to incomplete or improper actions during an investigation. All criminal justice personnel should be educated in the ethics and legalities of proper investigative techniques.
