# COURSE SYLLABUS

### NO TEXTBOOK

# **OBJECTIVES/GUIDELINES**

This course is designed to meet and exceed, in some respects, the minimum qualifications necessary for basic wildland fire suppression positions with State and Federal fire agencies. In addition, there are certifications for S-110, 130, 190 and "Standards for Survival". There is also a mandatory session in civil rights and sexual harassment which <u>all</u> students must attend to qualify as "trained fire fighters" with State and Federal fire suppression agencies.

For the duration of the course, a considerable amount of time will be spent in the field constructing hand lines under actual field conditions, and there will be several exercises at the school forest. To be successful, you must complete all segments of each unit of the course, including <u>all</u> field exercises. There will be at least two (2) all-day field exercises at the school forest at Sequoia Lake which will be required for full evaluation of field labs. There will be a four (4) mile hike the fifth or sixth week of class which <u>all</u> students are to attend.

Early in the semester, each student will be issued a Nomex fire shirt for use during the duration of the course. When you registered for the course, you were required to make a \$35 deposit for the shirt. Provided the shirt is returned in good condition at the end of the course, \$15 of the deposit will be returned. You will be required to wear the shirt to all class sessions and field exercises. A shirt not returned by the end of the semester will have no deposit returned, grades will be held, and the student will be billed for \$98 to replace the shirt.

For safety reasons, hardhats (approved by the instructor), serviceable work clothes (long pants with no cuffs and long sleeved shirt), and boots (laced, with lug soles) are <u>required for all field exercises</u>. In addition, <u>leather</u> work gloves are required for all field labs. All other safety equipment will be provided by the forestry department and used by <u>all students at all times</u> in the field. Details on where to purchase the above required items will be provided as the course gets underway.

We will be training in the use of fire hand tools and chainsaws. <u>All safety regulations will be strictly enforced</u> at all times. It would be wise to remember that the school forest at Sequoia Lake is at an elevation of 5,500 feet in the Sierras, dress accordingly.

Early during the semester, each student will be required to complete the Pack test for firefighter proficiency. All firefighters must satisfactorily pass the physical agility test before they will be employed by any fire fighting agency.'

#### **ATTENDANCE**

The class will meet **promptly** at 1200 each Friday, unless otherwise specified by the instructor. All-day field exercises will begin at 0700 and end at approximately 1700. It is the responsibility of the **student** to check on class meeting changes if they are absent at any time. Students are expected to be in class, properly attired (as outlined above), and ready for activities or field lab sessions **on time**. Attendance points for each class session will be awarded. Excused absences earn attendance points also. Only the following are considered to be "excused" absences: illness,

medical and dental appointments, death or serious injury/illness in the immediate family, and court appearances (on a case-by-case basis). Each of the above will be considered by the instructor as to whether or not it qualifies as an excused absence.

For any absence due to the above, students must contact the instructor at 638-3641, extension 3275 or 3310. Some make-up work may be allowed with the permission of the instructor. No quizzes will be made up. Regular tests/exams missed will have a one (1) week grace period with a 10% reduction in score; otherwise, **no credit** at all after that time.

If you arrive late to class, it is your responsibility to inform the instructor after class so your absence can be changed to a "tardy". After two consecutive weeks of absence, the student will be dropped. Reinstatement at that point is by formal petition only. Students will be dropped after any six (6) absences for non-attendance. Reinstatement can occur only if extenuating circumstances can be documented. Also, two tardies constitute one absence. The responsibility to drop the course lies with the <a href="student">student</a>. THE LAST DAY TO DROP A COURSE WITHOUT PENALTY IS FRIDAY, MARCH 10, 2000, BY 1700.

Quizzes will be given (unannounced) at the beginning of the class period. Tardy students will not have time to take a quiz after the allotted time is expended. Students are encouraged to arrive <u>on</u> to each class session.

## **COLLEGE POLICIES**

Campus code requires shoes (sandals accepted) and a shirt be worn at all times. Eating, drinking, or smoking (including use of smokeless tobacco products) is **NOT ALLOWED** in the classroom during class activities. No children and/or pets will be allowed to "sit in" and no animals are allowed in buildings. Smoking during field exercises will be rigidly controlled for fire reasons.

Also, no student may carry a knife of any kind with a blade which exceeds 3" in length. For <u>field</u> <u>exercises only</u> in the forestry program, you may carry a folding knife or sheathed knife.

A student must complete the entire course (including the final exam) in order to receive a passing grade.

If a student is caught cheating or plagiarizing another's work, he/she will be dropped from the course with a subsequent grade of "F".

No skateboards or roller blades, etc. are allowed in class or on campus.

## **INSTRUCTOR'S POLICIES**

As there is not a textbook for this course, it is very important that students attend all class sessions.

There will be no talking to associate students during class time. Repeated violations of this policy will result in dismissal from class at the discretion of the instructor for the student's return. No "horseplay will be tolerated at any time in class or in the field.

Male students will remove hats while in the classroom. No bandannas will be worn in class.

Anything you bring with you to class will be taken with you when you leave. If you have refuse to dispose of, there is a trash receptacle provided in the room for your use.

Misuse of equipment and/or supplies will be paid for by the student(s) responsible. This does not mean that equipment will not get damaged or broken through normal use, bur once a student is properly trained in the use of the equipment, **misuse will not be tolerated**.

Make-up work and some extra credit will be allowed for students wishing to learn a skill and work in the forestry tool/work room on tasks relating to the firemanship course. For each 1 hour worked, 5 make-up points will be earned (limit of 65 points possible). The credit given will be fore <a href="mailto:productive">productive</a> work only. Students will be supervised by an assigned tool room manager who is a student with experience and training in forestry. When students are working in the tool room, they are expected to treat the assigned student leader as a supervisor, not as a fellow student. Failure to do so will result in loss of extra credit privileges for the remainder of the semester or longer.

Missed field exercises can be partly made up by working on firemanship maintenance projects, at the above stated rates. Missed field final, or, but not both can be made up by requesting (in writing) an incomplete final grade. Then the student will make up the missing work during the next semester. These arrangements must be made prior to the final written exam time.

## **GRADING**

At the successful completion of the course, a letter grade will be issued. For those who warrant it, a certificate of completion for S-110, 130, 190 (Boise Interagency Course Standards) will be provided. In addition, there will be a two (2) hour certification course in civil rights and sexual harassment training and standards for survival which are required in order to be certified as a basic wildland firefighter by Federal agencies. Total participation in field activities, including day long field exercises, will be necessary to receive the qualifications for S-110 through 190.

In general, a passing grade of 70% is a "C". However, in order to pass the course with a "D" grade, a student must maintain an overall average of 55%. Grading is based on a sliding curve using the high total points awarded. In other words, if the highest total points earned by any student is 855, the bottom of the "A" would be about 770, etc.

#### FINAL NOTES

It is the student's responsibility to notify <u>all</u> instructors (in advance) of extended field trip absences.
