Highlighting the purpose and basics of accreditation

Services for Students: Standard IIB



Did you know that Student Learning Outcomes aren't just for classroom instruction anymore? No campus program escapes SLOs, and no area understands this better than Student Services.

Student Services encompasses many areas of

the college such as counseling, health services, financial aid, student activities, admissions, DSPS, and more. As folks from these areas work feverishly to finish their final draft for Standard IIB of the self study, they are evaluating issues such as student access to these services, diversity and civic responsibility, student confidentiality, and yes, SLOs.

The focus in accreditation has recently shifted from resource availability to how the programs support student learning. RC Student Services programs are creating PLOs and SLOs,

mapping them to GELOs, and are beginning to formulate timelines for the assessment of these outcomes. A division summit was held on November 12 that allowed areas a chance to get up to speed on these challenges.

Outcomes, Assessments, and Time...Oh, My!

In order to get Reedley College to the required "proficiency" level with our course, program, and institutional assessments, the ad-hoc Assessment Advisory Committee (comprised of Program Review and Curriculum volunteers) constructed the following timeline.

Fall 2010

- All Program Outcomes mapped to GE or Institutional Outcomes.
- Assessment and analysis of programs and courses

continued.

— Program and course begin implementing recommendations based on assessment.

— Begin mapping non-instructional Program Learning Outcomes to Institutional Learning Outcomes.

Spring 2011

- Assessment, recommendations, and implementation based on recommendations 50% complete.

Fall 2011

— Assessment, recommendations, and implementation based on recommendations 75% complete.

Spring 2012

— Assessment, recommendations, and implementation based on recommendations 100% complete.

Fall 2012

— Assessment, recommendations, and implementation based on recommendations 100% complete.
