<u>August 6, 2013 Board of Trustee meeting agenda</u> <u>2.1 presentations review</u>	Cabinet reviewed the board presentations for the August 6, 2013 meeting.
<u>Integrated Planning and Decision Making</u>	This item was moved to the August 9, 2013 Cabinet retreat.
<u>ASUR</u>	Dr. Blackwood provided an update on the ASUR process. The group is continuing to meet once a month. She asked Cabinet to reaffirm the composition of the team. Study session for the board will take place during the October 1, 2013 board meeting. Cabinet recommends Doris Griffin to replace Julie Preston-Smith. Tabatha Villalba will replace Paula Demanett.
