Prerequisite: A California Peace Officer Standards and Training Basic Course certificate issued from an accredited regional police academy or equivalent as determined by the division Dean or their appointee. These skills
and knowledge base are related to adopted POST and/or industry standards. Students must be advanced law enforcement certified SCUBA divers. NOTE: Approval of equivalent training is not a guarantee that state regulatory or licensing agencies will also grant equivalency.
Underwater search and recovery techniques for SCUBA diving in poor conditions, search and navigating underwater, and utilizing a helicopter during a search. (unique) (voc)
4. Administration of Justice 233P, Search \& Rescue Inclement Weather Update, 0.5 unit, 1.82.23 lab hours (Pass/No Pass), (Open Entry/Open Exit). Prerequisite: A California Peace Officer Standards and Training Basic Course certificate issued from an accredited regional police academy or equivalent as determined by the division Dean or their appointee. These skills and knowledge base are related to adopted POST and/or industry standards. NOTE: Approval of equivalent training is not a guarantee that state regulatory or licensing agencies will also grant equivalency. Law Enforcement search and rescue techniques for rescue of persons in swift water environments, snow, inclement weather, various terrains and interaction with helicopter or air support. (unique) (voc)
5. Administration of Justice 246H, MACTAC - Multi Assault, Counter Terrorism Action Capabilities, 0.1 unit, 0.47 lab hours (Pass/No Pass), (Open Entry/Open Exit). Prerequisite: A California Peace Officer Standards and Training Basic Course certificate issued from an accredited regional police academy or equivalent as determined by the division Dean or their appointee. These skills and knowledge base are related to adopted POST or industry standards. Multi-assault, counter terrorism capabilities overview related to the response to terrorism in the United States for local law enforcement. (unique) (voc)

Prepares students for entry-level positions in the field of behavioral health treatment for individuals with autism spectrum disorders (ASD). Students who successfully complete the course will have the training and experience required to be eligible to take the exam to become a Registered Behavior Technician (RBT). Provides students with foundational knowledge in autism spectrum disorders (ASD), applied behavior analysis, and evidence-based intervention techniques. (unique) (voc)
7. Fire Technology 233, Advanced Firefighter Continuing Education, 0.5-1 unit, 2-4.45 lab hours, (Pass/No Pass), (Open Entry/Open Exit). Prerequisite: Successful completion of a California State Fire Marshal's Office Accredited Firefighter 1 Academy or equivalent as determined by the Division Dean, Director or their representative. Note: Approval of equivalency training approval is not a guarantee of state regulatory or licensing agencies will also grant equivalency. Prior to beginning this course students shall be familiar with and be able to demonstrate all of the skill and general knowledge requirements of the California State Fire Marshals' Office 2013 Firefighter 1 curriculum. This curriculum is based on the National Fire Protection Association 1001: Standard for Firefighter Professional Qualifications, National Fire Protection 1051: Standard for Wildland Firefighting Personnel Professional Qualifications and the National Fire Protection Association 472: Standard for Competence of Responders to Hazardous Materials/Weapons of Mass Destruction Incidents. These skills will not be taught in this course; rather they will be the starting point for advanced training that build upon them. These subject areas are: Knowledge of Fire Fighter Safety, have the ability to don and doff personal protective ensemble and selfcontained breathing apparatus; knowledge of, and familiarity with fire apparatus and operating at an emergency scene; knowledge of, and familiarity with fire department communications equipment; knowledge and familiarity with firefighting tools and equipment; knowledge of and familiarity with structural fire suppression methods;
knowledge of and familiarity with firefighting apparatus; knowledge of and familiarity with firefighter survival self-rescue techniques as well as downed firefighter rescue techniques; knowledge of and familiarity with passenger vehicle fires and the hazards associated with them; knowledge and familiarity with wildland response and suppression methods, have the ability to don and doff wildland personal protective equipment and know its limitations; knowledge and familiarity with Hazardous Materials and Weapons of Mass Destruction Incidents.

## DEGREE APPLICABLE, TRANSFER

1. Agriculture Education 50 Agriculture Education Orientation, 3 units, 2 lecture hours, 3 lab hours. Advisories: English 125 and 126. This course is an overview of agricultural education in California, including the principle components of agricultural education, developing academic and career plans, and observation in a secondary agricultural education classroom. In addition to class time, the course requires a minimum of 45 hours of structured fieldwork in K-12 classrooms that represent California’s diverse student population, and includes cooperation with at least one carefully selected and campusapproved certificated classroom teacher. Students need to do their observation in a classroom that is in line with their degree plans. Single subject agriculture credential require that candidates observe in subject area at high school or junior high. This course requires verification of measles vaccination and pertussis, freedom of tuberculosis, and verification of flu vaccination within the past 12 months. (unique) (voc)
2. Business Administration 61 Field Studies in Business, 3 units, 3 lecture hours, pass/no pass. Advisories: English 1A and two of the following: Economics 1A, 1B, Business Administration 18. Stand Alone Course. This course provides opportunities for students to integrate their academic work with experiences in the business community; which is a key objective for Business Administration majors. To achieve this objective, students will research multiple industries within the business sector and interact with management level personnel in selected enterprises. Learning will occur both in and outside of the classroom. (unique) (voc)
3. Manufacturing 51 Manufacturing Essentials, 5 units, $\mathbf{3}$ lecture hours, 6 lab hours, pass/no pass. Prerequisites: Industrial Technology 205. Advisories: English 125, 126, and Mathematics 103. The study of manufacturing blueprints, materials, fabrication processes, and finishing techniques as used in today's industry. (unique) (voc)
4. Manufacturing 52 Manufacturing Fabrication, 4 units, $\mathbf{3}$ lecture hours, 3.33 lab hours, pass/no pass. Prerequisites: Industrial Technology 205 and Manufacturing Technology 51. Advisories: English 125, 126, and Mathematics 103. This course will provide instruction on metal fabrication. Instruction will be provided in the areas of welding techniques, project planning, sketches/working drawings, material selection, project layout, cutting, fitting, tacking, squaring, and finishing of student projects. (unique) (voc)
5. Mathematics 11C Elementary Statistics with Support, 5 units, 5 lecture hours. Prerequisites: Mathematics 103 or 211. Advisories: English 125 and 126. Fulfills RC's Math Competency Graduation Requirement. This course is an introduction to statistical methods and techniques with applications in the fields of business, behavioral and social science, as well as in science, technology, engineering, and mathematics. Topics include descriptive measures of central tendency and variability, probability, binomial and normal distributions, random variables, sampling, estimating, hypothesis testing
6. (parametric and nonparametric), correlation and regression, just-in-time-support learning and study skills. Not open to students with credit in MATH 11. (in-lieu FCC’s MATH 11, CCC’s MATH 11 \& STAT 7)
7. Plant Science 21 Fermentation Science, 3 units, 2 lecture hours, 3 lab hours, pass/no pass. Advisories: English 125, 126 and Mathematics 103. Overview of beer brewing, including history, malting, brewing, fermentation, finishing and packaging. In addition, sensory analysis, lab analysis and quality assurance in beer production. Course enrollment is restricted to students 21 years of age or older. (unique) (voc)
8. Plant Science 31 Prerequisite Programs for Food Safety, 1 unit, 1 lecture hour. Corequisites: Plant Science 32 and 33. Advisories: English 125 and 126. This course provides an introduction to food safety principles including identification of potential food safety hazards and sources of contamination, understanding the benefits of implementing Good Agricultural Practices (GAPs) and Good Manufacturing Processes (GMPs) into food operations, and identification of the U.S. Regulatory Agencies that enforce food safety standards. (unique) (voc)
9. Plant Science 32 Introduction to Hazard Analysis and Critical Control Points, 1 unit, 1 lecture hour. Corequisites: Plant Science 31 and 33. Advisories: English 125 and 126. Introduction to Hazard Analysis and Critical Control Points as a systematic and scientifically based approach to food safety through the identification, monitoring and corrective control of critical hazards in food production facilities. (unique) (voc)
10. Plant Science 33 Verification and Validation of HACCP Systems, 1 unit, 1 lecture hour. Corequisites: Plant Science 31 and 32. Advisories: English 125 and 126. Introduction to the verification and validation processes necessary to prove that a food safety management system is scientifically valid by gathering evidence to assure that safe food products will be produced once the food safety management system is implemented. (unique) (voc)
11. Plant Science 34 Internal Auditing of Food Safety Management, $\mathbf{3}$ units, 2 lecture hours, 3 lab hours. Prerequisites: Plant Science 31, 32, and 33. Advisories: English 125 and 126. An introduction to the knowledge and skills necessary to conduct an effective internal audit of food safety management systems to evaluate regulatory compliance, detect deficiencies, and implement corrective and preventative actions. (unique) (voc)
12. Speech Language Pathology Assistant 1 Introduction to Communication Disorders, 3 units, 3 lecture hours. Advisories: Eligibility for English 1A. Stand Alone Course. This course is designed to address speech and language disorders in children and adults. Topics include speech, hearing, and language disorders, trends in legislation and education, and a review of available community resources. The course provides information to the student exploring a career related to speech and language therapy. (unique) (voc)
13. Speech Language Pathology Assistant 2 Speech, Language and Hearing Development, 3 units, 3 lecture hours. Eligibility for English 1A. Stand Alone Course. This course is the study of speech, language and hearing development across the normal human life span. It includes genetic, cultural, and social aspects of communication development. Theories of language acquisition are discussed. Phonological, morphological, syntactic, semantic and pragmatic development will be considered and language sample analysis with typically developing children is practiced. (unique) (voc)

## NON DEGREE APPLICABLE, NON TRANSFERABLE

1. Mathematics 211 Pre-Statistics, 5 units, 5 lecture hours, pass/no pass. Prerequisites: Mathematics 250 or 252. Advisories: English 125 or 130 and English 126 or 128. Prestatistics, a non-STEM course, covers core algebra skills needed to understand the concepts, formulas, and graphs used in transfer-level statistics. Pre-statistics integrates numeracy, proportional reasoning, algebraic reasoning, and functions. This course develops conceptual and procedural tools that support the use of key mathematical concepts in statistics in a variety of contexts. This course is NOT intended for math, science, computer science, business, or engineering majors. (unique)
2. Mathematics $\mathbf{2 5 2}$ College Arithmetic and Prealgebra, 5 units, 5 lecture hours, pass/no pass. This course covers arithmetic and key concepts in elementary algebra which are typically difficult for elementary algebra students. Topics include arithmetic operations on integers, fractions and decimals, application of order of operations to simplifying arithmetic and algebraic expressions, solving linear equations, graphing linear equations, and applications. (unique)

This course examines the integration of personal financial management with physiological and psychological well-being, and the life-long impact financial decisions have on individuals, families, and society. Topics include time value of money; financial planning strategies; money and credit management; home ownership; home, health, and auto insurance needs; savings and investment strategies; and retirement and estate planning. This course will be taught in conjunction with English 1A College Reading and Writing. It will emphasize critical reading, expository and argumentative writing, and mastery of library research techniques. It includes instruction and practice in critical thinking, in analytical reading and evaluation of written work, and in the methods of clearly communicating and supporting ideas in organized, coherent essays.
3. Information Systems 20, Technology in Society, 3 units, $\mathbf{3}$ weekly lecture hours and 1 weekly lab hours. Advisories: Eligibility for English 125 and English 126. An introduction to the nature and function of technology, and the relationship between society and technology. This class will focus on the nature and impact of technology on society, paying particular attention to computing technology and digital communication while using previous technological advances as a basis for comparison. We will consider the social, business, computer science, political, historic, economic and philosophic contexts that both shaped and have been shaped by technological change. Students will explore the emerging field of technology and will learn procedures borrowed from business, computer science, sociology, psychology, and philosophy.

This course is designed to provide intensive instruction in critical thinking, reading, and writing as will be required in English 1A and other college-level courses. Using theme based readings from a variety of academic genres, coursework will emphasize independent reading of complex academic texts, critical response to ideas and information in academic texts, and writing essays that integrate ideas and information from academic texts.

## PROPOSED NEW COURSES

Effective Fall 2018

1. Geography 1, Physical Geography, 3 units, 3 weekly lecture hours. Advisories: Eligibility for English 1A recommended.
The course is a spatial study of the Earth's dynamic physical systems and processes. Topics include:
Earth-sun geometry, weather, climate, water, landforms, soil, and the biosphere. Emphasis is on the interrelationships among environmental and human systems and the processes and their resulting patterns and distributions. Tools of geographic inquiry are also briefly covered; they include: maps, remote sensing, Geographic Information Systems (GIS) and Global Positioning Systems (GPS) (In lieu FCC GEOG-1)
2. Geography 2, Cultural Geography, 3 units, 3 weekly lecture hours. Advisories: Eligibility for English 1A recommended.
This course is the study of diverse human populations, their cultural origins, diffusion, and contemporary spatial expressions. Topics include: demography, languages, and religions, urbanization and landscape modification, political units nationalism, and economic systems and development. (In lieu FCC GEOG-2)
3. Geography 10, Introduction to Geographic Information Systems, 3 units, 2.5 weekly lecture hours and 2 weekly lab hours. Advisories: Eligibility for English 1A recommended.
This is an introduction to the fundamental concepts, principles and methods of geographic information systems, focusing on the basic analysis, interpretation, display and communication of spatial information. Topics include the Identification and acquisition of GIS data, the assessment of different data types, understanding map projections and coordinate systems, and spatial analysis using GIS. (In lieu FCC and RC GEOG-10)
4. Geography 20, California Geography, 3 units, 3 weekly lecture hours. Advisories: Eligibility for English 1A recommended.
This course is a thematic approach to the state's issues, processes and topics relevant to geography including climate, landforms, natural vegetation, water resources, cultural landscape, ethnic diversity, urban and agricultural regions, and the economy. It explores the physical, and human landscapes that have evolved as a result of the humanenvironment interface. (In lieu FCC GEOG-20)
