 district strategic plan, facilities, technology, organizational reporting relationship of centers, location of signature programs, funding allocation, human resources and research capacity

In order to improve institutional effectiveness, the team recommends that the district document the process for review of board policies and ensure that district governance and decisionmaking processes are regularly evaluated

# Changes to the Accreditation Process

- The cycle increased from 6 to 7 years
- Implementation of new action "reaffirmation for one year" in lieu of always issuing sanctions
- Addition of a Quality Focus Essay (QFE) to describe 2 -3 projects to focus on over a few years.
- Progress on QFE and Student Achievement/Outcomes Data will be focus of Midterm Report
- More Training for Institutions
- Standards simplified to eliminate redundancies
- Standard IVC &D (District/Board) key themes
  - Regular Cycle of Evaluation
  - Regular Review of Key Indicators of Learning and achievement and institutional plans for improving academic quality (move from activity to outcomes)
  - Delegation of Authority
