The meeting was called to order at 3:32 p.m. by Dr. Hioco.

1. District Strategic Plan ~ Dr. P. Parnell

Dr. Parnell explained his focus is to work on the a, b, c d, e, 's

A = Accreditation

B = Board

C = Community & Communication

D = How we do things, data discussion, decisions

E = Equity

S = It's all about students.

Dr. Parnell emphasized the importance of strategic planning and how the strategic plan is the basis of what our mission and vision is.

Linda Cooley reviewed that at the November DSPC workshop the recommendation from that group was to have three overarching goals. These three recommendations would be considered the overarching goals for the strategic direction. The next step would be to create goals underneath the overarching goal areas. By having a concise, but comprehensive plan allows more flexibility for the colleges to align with the district plan. The three recommendations were:

- a. Excellence in Education
- b. Organizational Effectiveness
- c. Leadership in Higher Education and Community Collaboration

The next recommendation is to hold a community charrette in September to help push forward the goals.

Discussion took place regarding the timeline of preparing the district plan as the colleges have concerns about how they can move forward in developing their site plans without a district plan in place. The district goal is to complete this plan by the end of the fall semester so that alignment can take place with the colleges plan.

Concerns were raised by the committee regarding faculty buy in and the need for communication so that the faculty can have ownership of the document. It was suggested to create a document that summarizes the progress that has been made and where we are going and communicate that information to the constituent groups.

Educational Services will need help to pull this information together. The goal is to keep the information short, clear and succinct. <u>Linda Cooley will create a draft of talking points and send out for input.</u>

Dr. Hioco reviewed a proposed strategic plan timeline.

- a) Create a draft
- b) Who was invited to workshop
- c) Who attended the workshop
- d) Initial vetting to constitute groups.
- e) List of who would be invited to fall charrette during the summer
- f) Preparing the opening day statement at convocation

Dr. Parnell asked that once the timeline and talking points are completed to provide a copy to him to share with the Board at their summer retreat.
