### COURSE DESCRIPTION

THE HISTORY AND PHILOSOPHY OF THE ADMINISTRATION OF JUSTICE AS IT HAS EVOLVED THROUGHOUT THE WORLD; AN IN-DEPTH STUDY OF THE AMERICAN JUSTICE SYSTEM; ROLE CONCEPTS, EXPECTATIONS, AND THE INTERACTION OF THE SUB-SYSTEMS WITHIN THE CRIMINAL JUSTICE SYSTEM; CRIME CAUSATION, PUNISHMENT AND REHABILITATION; ETHICS, EDUCATION AND TRAINING FOR PROFESSIONALISM IN THE SOCIAL SYSTEM.

### COURSE OBJECTIVES

STUDENTS WHO SUCCESSFULLY COMPLETE THIS COURSE WILL BE ABLE TO DEMONSTRATE A KNOWLEDGE OF THE EVOLUTION OF THE ADMINISTRATION OF JUSTICE SYSTEM. THEY WILL DEVELOP AN AWARENESS OF THE OBJECTIVES OF THE SYSTEM, INCLUDING AN AWARENESS OF SOCIAL ISSUES PERTAINING

TO IT AND THE INHERENT CRIME PROBLEMS WITHIN OUR SOCIETY. THEY WILL ALSO GAIN AN UNDERSTANDING OF THE ROLE EXPECTATIONS OF CRIMINAL JUSTICE PERSONNEL, AND THE DEMANDS AND REQUIREMENTS OF THE VARIOUS CAREERS WITHIN THE JUSTICE SYSTEM. THE STUDENT WILL GAIN AN APPRECIATION FOR THE NEED OF A WELL ORGANIZED ADMINISTRATION OF JUSTICE SYSTEM, AND ALSO FOR THE NEED OF HIGHLY EDUCATED AND TRAINED PROFESSIONAL PERSONNEL TO WORK WITHIN THE JUSTICE SYSTEM.

TESTS AND EXAMS: THERE WILL BE AN ANNOUNCED DATE AND A WRITTEN TEST GIVEN FOR EACH UNIT OF THE COURSE. THERE WILL BE OCCASIONAL UNANNOUNCED CHAPTER QUIZZES.
