Course Description: This is an introductory course in microeconomics. This course focuses on individual economic decision and choices. Topics include: scarcity, elasticity, firm and cost theory, market structure, factor markets, comparative advantage, market equilibrium, and international economics and finance.

Learning outcomes: Upon completion of this course, students will be able to:

- Illustrate elasticity of demand and supply
- Interpret market structure and how the markets operate
- Construct production costs and optimization
- Evaluate the impact of regulatory policy on the economy
- Identify the factors that contribute to or hinder international economic growth and development
