Description

Math 11 is an introduction to statistical methods and techniques for business, behavioral, and social science majors. Topics include descriptive measures of central tendency and variability, probability, binomial and normal distributions, random variables, sampling, estimating, hypothesis testing (parametric and nonparametric), correlation and regression. - 5. Explore the basics of sampling theory.
- 6. Estimate population parameters through studying confidence intervals.
- 7. Examine hypothesis testing for small and large samples and multiple populations.
- 8. Determine if a relationship exists between quantitative variables.
