Course Description:

A theoretical and conceptual overview of multicultural issues within the public safety disciplines. The identification of potential problems raised in those areas when dealing with a diverse population. The study of varied strategies used to overcome those problems, particularly in relation to the maintenance of social order.

Student Learning Outcomes:

By the end of the semester, it is expected that the student will:

- Evaluate and develop techniques to communicate more effectively with people from various cultures and ethnicities for better relationships between the community and the criminal justice system.
- Use and evaluate the vocabulary of the various cultures and ethnicities within their communities, as well as the vocabulary of the criminal justice system.
- Describe ways in which culture and ethnicity impact relations between community and criminal justice professionals.

Learning Objectives:

At the end of the course, the student will:

- Analyze the historical concepts of multi-cultural interactions as they apply to criminal justice.
- Identify and differentiate various cultures and the recommended procedures to follow for effective interactions.
- Use the various related codes (hate crimes, terrorism, etc.) appropriately.

Methods of instruction:

- Lecture
- · Reading assignments/handouts
- Video presentations
- Class discussions
- Guest Speakers
- Scheduled ride-along with local police agencies (field experience).

Required Text and Materials:

Assignments are embedded in the required textbook. Students are encouraged to purchase or familiarize themselves with the campus resources available early on. You must get your work done by the end of the week the assignment or exam is expected to be completed. Your grade will be based on successful completion of the following:

- Weekly Assignments:
 - Each week you will be given a weekly assignment which must be completed during the week. These weekly assignments will be scored. They will generally be relatively simple. **They will** have a due date that may not be missed.

- I will use the completion of these weekly assignments to track your attendance for this class. Failure to complete the assignment for the week will count as an absence for the week. Weekly assignments are worth a total of 150 points.

• Participation:

- 180 total points
- Student participation in discussions is critical to the assimilation of the material covered. All the students in the class are asked questions regularly to understand the topics discussed. If called upon by me to answer a question or offer a thought on the subject at hand, you are expected to give a coherent response. Simply shrugging your shoulders is not acceptable. Additionally, if you are not present, you are unable to participate. When called upon, you must be present and participate to earn participation points for each class session.
