A journey back in time...

...to the birth of cinema, through the early decades that paved the way for modern movies. Film 2A is a class that informs students on the history of movies...where and how they started with particular attention to how technological advancements shaped the medium over time. It will cover the key people and events that impacted cinema through a filmmaking industry that is a conflation of art and business. The class will also analyze how movies act as both an influence and reflection of the society (and history) from which they were made.

Upon successfully completing this class, a student should be able to identify and analyze significant moments in the development of film technology, the evolution of genres (with respect to a film's historical and social context), the fundamental elements of film form and style as well as the development of key filmic techniques and also report (in chronological order) the main currents of early film history.

Student Learning Outcomes:

- Identify and recognize the main events of early film history, the birth and development of genres, and the significant developments in film technology.
- Identify and analyze cinematography and editing techniques used in films to create intention and meaning.
- Complete 2000 words of essay prose using MLA format and citations, with a clear thesis and supporting evidence, focused on film analysis (which includes film form and style) as it relates to the history of film.
- Analyze films and filmic techniques from diverse interpretive angles such as historical impact, cultural or artistic influence, or intention vs. audience comprehension. Discover the hidden social values of films through the study of their criticism.

Textbook: American Film: A History, 2nd edition, Jon Lewis
