Writing Assignments/Responses/Analyzations: You will be required to demonstrate understanding and application of course content through completing writing assignments/responses/analyzations. These assignments will require the student to use responsive and critical thinking skills in describing and understanding the child's physical, cognitive, social, and emotional development. The use of academic directive word prompts such

as analyze, assess, criticize/critique, compare/contrast, define, describe, define, discuss, enumerate, evaluate, explain, interpret, identify, justify, outline, respond, state, summarize, synthesize will be implemented and required in writing assignments.

- 1. <u>Articles:</u> You will be required to complete 3 articles relative to "Health, Safety and Nutrition in Early Child Education."
  - The articles are not to exceed more than 1 page. Additional information will be provided.
- 2. <u>Exams</u>: There will be a total of 3 exams. Exams will be made up of multiple-choice questions related to the materials covered in class. It is recommended that students attend class meetings in preparation for the exams. Exams will be given on the canvas platform on line and *no make-up exams will be given* (see Course Outline and Schedule for exact dates).
- 3. <u>In-Class Assignments:</u> We will have many opportunities for in class participation during the semester. I will randomly award points for your participation in these assignments. If you are not in class you can't participate which means you miss the points for that assignment.
