Highlighting the purpose and basics of accreditation

Leading the Way: Standard IV



No institution is effective without good leadership and governance, and that is what Standard IV of the accreditation self study must examine.

The first part of the standard takes a critical look at decision-making roles and processes of the college. Reedley College must provide evidence that its leaders create an empowering environment of institutional excellence. The college must show that all employees (and some students) have a chance to participate in planning and making decisions. Additionally, the college must show that the processes surrounding these decision-making procedures are evaluated regularly.

The second half of the standard deals with how Reedley College interacts with its Board of Trustees, district, and administration. The board and district must have established policies that assure quality, integrity, and effectiveness. This standard also takes a look at how well the president of the college provides leadership in

planning, organizing, budgeting, selecting/ developing personnel, and assessing the effectiveness of the institution.

This standard is unique in that it deals with district operations in addition to college-wide leadership. Because of this, Reedley College, Fresno City, and Willow International are working with Shelly Conner, the SCCCD Director of Grants and External Funding and Accreditation Liaison Designee, to assure consistency in completing the district-related portions of this standard.
