 - The Reading and Languages Department had several comments.

 - President B. Turini stated that Career Technical Education is the new term for Vocational Education.
 - Reedley College President Dr. B. Hioco stated that the reason why "to all can benefit" was added was due to a guideline from ACCJC that recommends a college mission statement identify the students it serves.
 - 8.3. Revised Core Values Statement (referred by College Council)
 - The Math and Technology department
 - Core values read more like goals.
 - Should not include action verbs. Suggest deleting verbs.
 - Reading and Languages Department
 - Agreed with the recommendation to delete the verbs.
 - Change last bullet from "quality student services" to "services for students to support and enhance their success".
 - 5th bullet change "reflect" to "promote" or "support" diversity
- 9. New Business
 - 9.1. SLO/PLO/GELO Reporting Grid (referred by the Program Review Committee)
 - Form created to map SLO, PLO and GELO to courses. North Center started using this form during duty day. This form will help align our reports across locations. It is an extension of the mapping that was done in Cycle 2 of Program Review by adding GELO's. Senator R. La Salle moved to suspend the rules and take action in one hearing. (M/S/C: R. LaSalle, C. Elliott) motion approved by 2/3 majority. Senators L. Novatne L. Obid raised concerns over not being able to take the form back their departments for review. Motion to Approve Reporting Grid Approved (M/S/C: T. Mester, R. LaSalle) 4 oppose, and 3 abstentions.

- 10. SPECIAL ITEM –Report on SCCCD and Reedley College –Reedley Campus faculty hiring policies, regulations and practices
- It was requested at the last Senate meeting that a report be provided on the local practices for faculty hiring including prioritization and district policies. These questions arose last semester during the hiring of a baseball coach/instructor.
- Special Guests invited were RC President Dr. B. Hioco, Vice President for Student Services M. White and Assistant Vice Chancellor R. Rowe since they corresponded and met with Senate President B. Turini this summer on these issues.
- Instructor and Department Chair R. Elizondo asked to give some background on the local prioritization process through Department Chairs. She stated that Department Chairs last semester met and reviewed written and oral presentations on requests for new faculty. Department Chairs understood that there were four positions open 1. PE Health Football (due to move to administration), 2. Criminology (due to retirement), 3. Biology (due to transfer), 4. Environmental Horticulture (due to retirement). The PE position was filled by a FCC transfer and the Criminology and Biology positions were opened for applications. The decision on the fourth position was delayed. On May 6, 2010 an emergency Department Chairs meeting was held where Department Chairs were informed by Dr. Hioco that the final position had been designated as Baseball Coach/ Instructor without further discussion. Meeting notes for the January 19th and May 6th Department Chairs meeting were made available to senators on Blackboard. Also available online is the Board Policy on the Hiring Process and AR 7120.
- Maria Kelly asked about the makeup of the hiring committee. President B. Turini stated that the committee did confirm to the required ratio between faculty and administration (1 administrator, 7 certificated faculty and 1 classified member). The Senate Executive Committee had concerns over the constitution of a committee without a degree emphasis. The committee was finalized after human resources reviewed the applicant pool. When it was determined that the only applicants qualified for the position were from Physical Education due to the requirement of that position to teach a baseball theory course.
- Senator L. Novatne asked about the local prioritization process. Dr. Hioco stated that the faculty hiring process and forms need to be reviewed. The current process is that the Department Chairs prioritizations go to the College President as a recommendation. There was a PE position on the prioritization list last year. The PE position was ranked number eight out of nine. Dr. Hioco met with the Department Chairs to announce her final faculty hiring decision on May 6, 2010.
- Maria Kelly asked Dr. Hioco for an explanation as to why she deviated from the prioritization list. Dr. Hioco stated that she believed that for college and the baseball program needed a couch. Maria Kelley asked, in light of the number of class sections cut this year, could we have not hired a coach for a year and rescheduled some of the lost classes.
- Michael van Wyhe stated the faculty staffing request that was presented at Department Chairs was for a PE/Cross Country Coach. Department Chairs only met formally twice during the spring semester. Michael van Wyhe stated that the minutes for the January 19th meeting did not reflect all the comments and discussion. During the presentation by the Chair of the Health Sciences and Physical Education department he stated that this position was not urgently needed but that he wanted to get it on the table. Dr. Hioco stated that hiring a cross country coach would have required Reedley to add a new sport. Dr. Hioco stated that there was no requirement that she take the issue back to Department Chairs when she changed the position from PE/Cross Country Coach to Baseball Coach/Instructor.
- President B. Turini and Dr. Hioco have already discussed the need to review and define more clearly the faculty hiring process.
- Senator L. Obid asked if it would have been possible to hire an adjunct baseball coach instead of a full time position. Dr. Hioco stated that her decision, based on what she thought was best for the college and the baseball program, was to have a full time instructor/baseball coach. Lacy Barnes noted that the Head Tennis and Head Golf Coaches are both part time instructors.
- Maria Kelly asked Dr. Hioco to clarify that she believed at that time at Reedley needed an athletic coach more than an academic instructor. Dr. Hioco stated that she did.
- Rose Elizondo asked how many students were in the baseball program. M. White stated that there were around 50 students in baseball. Dr. Hioco reminded that the coach would also be teaching academic classes. Lacy Barnes asked how many adjunct instructors were lost due to the addition of a full time instructor. It was also asked if we had to add PE classes to make up the load. M. White stated that one adjunct declined the offer of 4.5 LHE and two adjuncts lost 1.5 LHE. Senator J. Hacker stated that they did have to add a PE class and that the new baseball coach is only teaching activity courses this semester, no lecture courses. Maria Kelly stated it seemed that we had the need for a new coach but not a new instructor.

- Dr. Hioco stated that they tried to open the position to all academic disciplines by designating it as Instructor/ Baseball without a specific discipline. It did not work and Dr. Hioco committed that they would not try it again.
- Lacy Barnes stated that is important that all decisions take into consideration how they impacts the most students and should encapsulate the mission and core values of the college. Dr. Hioco stated that she did take into account the college, faculty and students when making this decision. She acknowledged that this was not a popular decision.
- Senator D. Meier stated that we should all remember that the number of students in the baseball program is not relevant. They are all part of the college community. They are not only baseball players they are also academic students. He stated we go down a dangerous path when we state that a program or a group of students has merit due to the number of students since they are all part of this school. We are serving the community by offering athletics like baseball just as much as we do by offering academic programs.
- Maria Kelly stated that due to the controversy it would have been appreciated if the College President had sent an e-mail to faculty during the summer regarding the decision.
- Senator J. Hacker stated that he had a faculty evaluation in March of 2009. There were no issues brought up during this evaluation. He was replaced as baseball coach a year later. Senator J. Hacker stated that he spent his tenure as baseball coach trying to give the students the full college experience both athletic and academic. As Head Baseball Coach he stressed the importance of academics over the number of wins and losses.
- Senator S. Jeffries states that faculty in the Health Sciences and Physical Education department are confused on the criteria for performance they will be evaluated on as instructors and coaches.
- President B. Turini stated, in closing, that this discussion has brought up issues that need to be addressed by a committee. President B. Turini asked departments to send comments and nominate names for this future committee to review the faculty identification and approval process.
