- 5. Presidents Report
  - 5.1. SCCCD Communications Council,
    - Focus of last meeting was District Strategic Planning and coordinating across the district. Each location on the district has a different Strategic Plan timeline. SCCCD Chancellor Dr. Blue wants a more definitive plan rather than a rolling plan. President Turini asked about sabbaticals and whether there was going to be any guidance from the district regarding previous sabbaticals. The Chancellor stated that she would consult with Associate Vice Chancellor for Human Resources Randy Rowe and Federation and there may be guidance coming from the district. Senator J. Hacker recommended that the Senate make a resolution to state that the previously funded sabbaticals should be given first priority. President B. Turini suggested that this could be an agenda item for a future Senate meeting.
  - 5.2. SCCCD AR 7120 Review Committee Appointments
    - The number of faculty appointments is still being reviewed. President B. Turini has told Associated Vice Chancellor R. Rowe that if the NC Vice Chancellor is a member of the Committee that NC Faculty needs a designated position. So far President B. Turini and Maria Kelly have volunteered for the committee. A North Center volunteer is requested. President B. Turini will be an alternate depending on the final committee compensation.
    - Faculty Prioritization Process. President B. Turini has discussed with Reedley College President B. Hioco the need for a "well defined process" for faculty prioritization. He suggested to the College President that the senate recommend the process by which we review the process. Senators were asked to take this topic back to their departments and return with recommendations. Maria Kelly suggested that any review group should include current and former Department Chairs since they have experience with the current process.
  - 5.3. Town Hall Meeting 9/22/2010
    - Addressed issues of Accreditation. This Town Hall focused on Standard I and IV. A Progress Report was given by Standard Chairs.
