## Mission Statement

The State Center Community College District (SCCCD) Transition to College (TTC) program strives to promote and reinforce in students the characteristics of self-reliance and independence when making the transition from high school to post secondary education and training.

## What is Transition to College?

Transition to College is a one unit course designed to assist students prepare for their initial semester in a community college and navigation of the State Center Community College District campuses, resources, academic policies, procedures and services, with emphasis on DSP&S services, resources and accommodations available for students with disabilities.

The course is typically offered during the spring semester at high school campuses throughout the State Center Community College District service area (Fresno, Clovis, Madera, Oakhurst, Reedley and other nearby communities). However, the course can be offered at other locations, for any age student, preparing to enter the community college district.

## Who is eligible to participate in Transition to College?

The course content is designed specifically for students with a diagnosed and verified disability. However, all students are eligible to participate in Transition to College for Students with Disabilities.

## How do students benefit from Transition to College?

Students benefit through increased understanding of issues related to enrolling and attending college. This course specifically addresses reasonable academic accommodations and introduces potential students to the resources available to students with disabilities, enabling them to be more successful in a college setting.



## Topics covered in the Transition to College class include:

- Application process
- Assessment and Placement test
- Financial Aid applications
- Campus resources and how to access them
- Services and accommodations available through DSP&S
- Request process for on-campus accommodations
- Campus tours
- Utilizing the college catalog and schedule of courses
- Development of a Student Education Plan (SEP)
- Class selection and registration
- Appointment with DSP&S counselor

## What are the benefits for high schools supporting the Transition to College program?

SCCCD understands the need to assist local high schools and their students with disabilities and are therefore committed to assisting with the transition process before the student leaves high school.

High schools receive on-site support, are provided with a Transition to College contact and post secondary support when creating their transition plans. This option provides a stronger support system for teachers, case managers and students.
