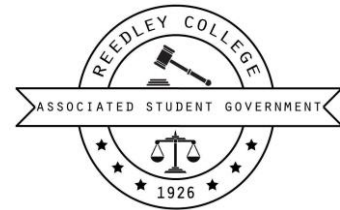
**7.3 - BP and AR 4225 abd BP and AR 4230 Discussion with possible action / 15 min / Stephen Kodur )**

- With No Objection, President Litt would like to approve 600 dollars for school supplies

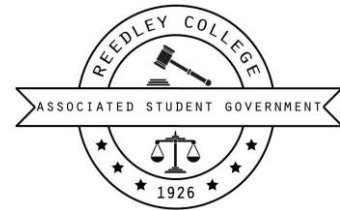
### 9.2 - Student Activities Free (Discussion with possible action / 15 min / President Litt)
