January 7, 2013

<u>January 8, 2013 Board Agenda</u>	Cabinet reviewed the January 8, 2013 board agenda. Dr. Railey reviewed the details of the strategic conversation event, set for February 5, 2013.
<u>3.1 Strategic Conversation presentation</u>	Brian Speece reviewed the safety and security update presentation.
<u>3.2 Safety and Security Update</u>	Dr. Blue reminded Cabinet about the board development workshop and stated they should attend. The workshop will take place on January 15, 2013 at 2:00 p.m.
<u>Board Policy Updates</u>	Mr. Taylor stated he will be distributing to Cabinet policy updates from CCLC that have yet to be incorporated into the district's policies next week. He asked Cabinet to look at the policies and see if they want to make recommendations for inclusion of any of the league's policies in the districts AR's and BP's. Dr. Blue asked Mr. Taylor, Ms. Clerou, Dr. Railey and Mr. Eng meet to establish a process and timeline for addressing new recommended policies on an ongoing basis.
<u>Negotiations Update</u>	Ms. Clerou provided a negotiations update.
<u>New Trustee Orientation Part II</u>	Dr. Patterson reviewed the agenda for the part II of the new trustee orientation, scheduled for January 10, 2013.
<u>Chancellor's Cabinet Retreat</u>	Dr. Blue stated the goal isto have Cabinet's retreat prior to the Board's retreat in order to prepare items, especially financial information. She recommended having the retreat on a Monday. Recommended dates will be sent to Cabinet members this week.
<u>Counselors of Real Estate</u>	Mr. Speece asked the campuses for their prioritized projects.
<u>Around the Table</u>	Dr. Railey stated the Fresno Regional Workforce Investment Board approved three training contracts with FCC. The total amount awarded is \$383,000. The three classes are Machining and CNC, Maintenance and Light Repair, and another cohort of PG&E Lineman. Ms. He'bert reminded Cabinet about the Peter Buffet event on February 2, 2013 and Renaissance Feast on March 9, 2013. Mr. Eng stated the governor will be unveiling his budget this month. Mr. Speece provided an update on police services and campus incidents.
