## DISTRICTWIDE ENROLLMENT MANAGEMENT TASKFORCE CHARGE

The Districtwide Enrollment Management Committee will operate on a strategic level focusing on districtwide enrollment management issues, and recommend to the Chancellor's Cabinet districtwide initiatives and enrollment strategies to support the achievement of the District's annual enrollment goals.

## The charge of the Districtwide Enrollment Management Committee it to:

- recommend a SCCCD definition of Enrollment management.
- assess and recommend districtwide policies and procedures as they affect enrollment management, student access, persistence, and retention.
- recommend districtwide initiatives and enrollment management strategies to increase student access, persistence and retention.
- establish and maintain ongoing dialogue regarding districtwide enrollment management to increase understanding of enrollment funding issues in a systematic, comprehensive manner.
- develop a districtwide strategic enrollment management plan that is guided by the District's Vision, Mission, (Values) and Strategic Directions.
- facilitate the coordination of districtwide and college enrollment management planning.
- assess districtwide progress toward achievement of annual enrollment goals.
- recommend annual districtwide initiatives that support the enrollment management plans of the colleges.
- monitor districtwide enrollment reports, identify issues and develop recommendations for addressing issues.
- recommend districtwide target marketing, outreach, recruitment, enrollment, financial aid and other strategies to stabilize or increase enrollment.
