- 1. Report of the C6 Grant Update
 - C. Kralowec was not present to provide an update.
- 2. CTE Survey
 - P. Avila asked to revisit the survey. He has spoken with Chuck Wisely and clarified the students with BOG and VETA. There are about 18,000 students per year that are A B C and of those 66% are getting waivers. He explained how many students and the funding.

Discussion took place to possibly identify students and send them an on-line survey. We would receive \$100 is probably minimal effort. The issue is on the coding of the sections.

He would like this group's input into how we protect our data.

Lijuan we need be proactive. We need to talk about data security. It is very important.

Discussion took place of possibly having an IT summit to talk about technology, opportunities and challenges and importance of having protocols.

R. Torres can we seek programs that can access the system that doesn't download the information, but can drill into the system to gain access for the research staff. There is no policy on logging into the system from a remote location.
