<u>Administrative</u> <u>Regulation</u> <u>2410</u>	Mr. Taylor asked if Council received feedback from their constituency groups. Ms. Habib advised the second read will not be until August. Chancellor's Cabinet is currently reviewing the policy in preparation to take the item to the July Board meeting. Mr. Taylor stated input on these is not required by Communications Council.
<u>Consultants and</u> <u>Hiring</u> <u>Processes</u>	Mr. Turini stated there are concerns about the way consultant navigate the selection process. During the Reedley College presidential search, the committee did not designate a chair. Mr. Turini referred to AR 7220. Dr. Blue said the AR was written for the internal process, not including consultants. She said one reason to use consultants, is because they have access to a larger pool of qualified candidates. Mr. Turini asked if a consultant could be hired to establish a pool, and not guide the process. Dr. Blue said yes, and that it would be cost saving as well.
<u>District</u> <u>Governance</u>	Dr. Blue said a district governance group was a recommendation from the result of the 2008 strategic plan update. Dr. Blue asked Council if they were ready to take a look at models. Dr. Barnes volunteered to chair the sub-committee and research district governance models. Kasey Oliver, Claudia Habib, Greg Taylor, Tony Cantu, and Melanie Highfill agreed to serve on the sub-committee. Dr. Barnes will ask Dr. Kershaw if he would like to serve on the committee, or designate a member for the North Centers.
<u>Around the</u> <u>Table</u>	Dr. Barnes expressed concerns about board agenda items involving grants. She asked if the grants had the potential to create more work for existing staff. Dr. Blue stated she will have a discussion with Shelly Conner about the grant process and Dr. Barnes' concerns.

Mr. Turini asked if the District supported AB515. Both the Academic senates and Federation request to know the District's position on senate and assembly bills. Dr. Patterson in a follow-up email responded to Council stating, historically with a few exceptions, the District has taken positions on legislation in alignment with the recommendations of the League and/or the State Chancellor's Office. It is not uncommon for different constituency groups within a district to have opposing views on various legislative issues.
